FARM EMERGENCY PREPAREDNESS SAFETY CHECKLIST

Is your farm ready in the event of an accident, fire or a force of Mother Nature? Many times we take for granted being prepared for these unforeseen incidents. A little time planning up front can help you respond quickly and effectively when needed. Also, be sure to have a training program for new employees and go over your plan annually. A little time can save a life! Be proactive and review your emergency preparedness plan today.
